PASTOR

I want to use this newsletter to talk about the Army Reserve unit I was assigned to as a chaplain, and what my ministry there will be. I was assigned to the 120th Infantry Brigade of the First Army. It is stationed on North Fort Hood, and its mission is to prepare units from around the nation to deploy. I recently attended my first Battle Assembly. I will be utilized mostly on Fridays and Saturdays, once a month, in support of other chaplains also assigned to the unit. I have been asked to lead chapel services, bible studies, and provide pastoral care for these soldiers preparing to deploy.

As we consider how the Army Reserve will fit into my calling as your pastor, it is helpful to consider the mission we have already done at Bartlett State Jail. On average, I would spend five to nine days a month ministering to prisoners at the jail, with the Faith Based Dorm program, and the Kairos weekends. You also participated in this Christian outreach to prisoners with cookies, and volunteering at the church at the start of these Kairos weekends. It was a mission which proclaimed the gospel to men incarcerated here in Bartlett.

The Army Reserve chaplaincy is also a Christian outreach, but to soldiers training to deploy. They too are separated from their families, and in need of pastoral care, and of hearing the gospel proclaimed in words and actions. The Army Reserve chaplaincy will require some of my time. Yet, with the prison closing, I have the available time for this new mission, and like Bartlett State Jail, it can be balanced with my ministry as your pastor. I thank you for your support of this new outreach and ministry.

Property Committee: Bill Wooley reported for property. The only repairs this past month were to the pastor's mailbox; a bolt was replaced and a few others tighten and the mailbox is now good as new.

Youth Committee: Kristi Dague reported that the youth have agreed to be in charge of the dessert sale at the Polka Worship; all members of the church will still be donating baked goods. Confirmation Class had just returned from summer camp at Camp Ebert and everyone had an enjoyable time.

Stewardship & Public Relations: Pat Stroud reported to the council that donations for Family Promise were down in the last month; need to spread the word about donating.

Membership & Fellowship: Cedalia Kurtz reported that the committee working on the membership list/book have met to finalize the list. Meals have been taken to the home bound.

Worship Report: Donna Campbell reported to the board that she and Dotty Kneten had met on May 22nd at 1:00PM to prepare the schedules for July, August and September, 2017. Donna stated that there would be one additional 2017 schedule to plan, for Oct./Now./Dec.

Parish Ed.: Frank Horak was absent, no report presented.

President Kurtin asked for a motion of adjournment. Kristi Dague made a motion for adjournment, seconded by Donna Campbell. The motion carried. Council adjourned at 7:25P.M.




